UKS2 RESIDENTIAL 2025- YORK

YEAR 5- Monday 10th March – Wednesday 12th March 2025

Dear Parent/Carer,

We are excited to share with you next academic year's UKS2 residential will be to York. Residentials in UKS2 are on a rotation between our learning cycles, meaning that by the end of the 2-year cycle all children will have experienced both a visit to Whitby and York. In addition to this, our Trust continues to plan to once again run a fully-funded one-night summer term residential next year- more details to follow in the Spring.

We will be staying at The Stableside, which is in a beautiful location right next to York Racecourse and this will be on a full board basis. During the visit, we will take part in lots interesting and exciting activities including visiting York Chocolate Story, DIG and York Minster.

We are unable to give a confirmed final price of the trip until we have received all deposits and know final numbers, but we estimate this to be around £180 per child. We are mindful that this is a small increase from the previous York residential price in 2023, however the rising costs of transport, goods and services has resulted in the accommodation options and attractions in York increasing their prices.

With this in mind, we are needing to identify interest and the number of pupils accessing the visit earlier than normal to confirm the residential will go ahead as planned. If you wish for your child to attend the York residential, please can you complete the Google Form following the QR code below or the link <https://forms.gle/u4bZao5GuZesh8FH6> and pay a non-refundable deposit of £20 by Monday 15th July. This can be paid on ParentPay.

Once we have received deposits, we will then be able to work out a final price for the visit per child and will give information about how much each instalment will be.

Deposit due- Monday 15th July 2024

2nd installment due- Monday 23rd September 2024

3rd installment due- Monday 2nd December 2024

Final instalment due – Monday 13th January 2025

Please note that the full price of the trip will apply unless you have contacted us in advance.
